The undersigned respectfully applies to this Court for an Order authorizing the installation and use of a mobile tracking device under Florida State Statute 934.42. The following is a factual basis underlying this request:

- The undersigned, FWC Officer Jeffrey R. Gier, of the Florida Fish & Wildlife Conservation Commission is authorized to enforce the laws of the State of Florida. FWC Officer Jeffrey R. Gier, is currently conducting an ongoing criminal investigation under the Florida Fish & Wildlife Conservation Commission case number FWNE-11-OFF-2628, and certifies that the information likely to be obtained is relevant to that ongoing criminal investigation.
- 2. FWC Officer Jeffrey R. Gier, certifies that he has obtained reason to believe that a suspect in the investigation is committing criminal acts of Hunting While Under a Fish & Game Compact Hunting Privilege Revocation/ Suspension within the County of Volusia, Florida, contrary to

Florida State Statute 379.354 (17). The subject Pleamon Frank Hamlin's hunting privilege was revoked on March 17, 2011, as part of a plea agreement in Tennessee. He signed two court documents acknowledging the suspension/ revocation on March 17th (please see attached documents). He was further advised that Florida was a Game Compact State along with Tennessee and that he would not be allowed to hunt in Florida by Tennessee Wildlife Resources Officer Amy Snider. Upon March 19, 2011 he purchased a Florida non-resident hunting license and a Florida non-resident turkey stamp. William Tallie Lewis is acting as Hamlin's guide and Hamlin is staying at Lewis' residence. This information was gathered through investigation. Also, it supports the fact that the suspect utilizes the aforementioned vehicles while committing those illegal acts. This investigation is as follows:

- 3. FWC Officer Jeffrey R. Gier, advises and requests this Court allow the law enforcement or its designees to install, remove and reinstall the device for a period of surveillance and periodic maintenance needed for the duration of this thirty (30) day period.
- 4. FWC Officer Jeffrey R. Gier, seeks to identify the aiders, abettors, or coconspirators that the suspect may meet with and he seeks to identify the locations of those meetings. He also seeks to identify the hunting location of the suspect. This request is made in good faith and for legitimate law enforcement purposes.
- 5. FWC Officer Jeffrey R. Gier, also seeks to use and monitor the mobile tracking device outside of the County of Volusia should the suspect leave the county during the course of the investigation. The installation will occur within the County of Volusia.
- 6. FWC Officer Jeffrey R. Gier, requests the order for a duration of thirty (30) days.

Whereof, your Affiant makes this affidavit and prays the issuance of a mobile tracking device on the above-described vehicle.
